

TENDER NOTICE
OFFICE OF THE DEPUTY COMMISSIONER, BHAKKAR

The District Administration, Bhakkar intends to install CCTV (Security cameras), along with accessories, at various vulnerable points (about 96 points), throughout district Bhakkar. It needs to procure following services/goods for implementation of its "Brave the Save Bhakkar" program amounting to Rs. 4.5 Million approximately. The sealed tenders, as per single-stage-two-envelop procedure as prescribed in PPRA Rules, 2014, are invited from Sales Tax/Income tax registered experienced manufacturers/authorized dealers/supplier firms/person(s);

- i. To survey the pre-identified points/locations for installation of CCTV security cameras in the district.
 - ii. To install CCTV cameras at all identified points/places in the district.
 - iii. On-line networking of CCTV security cameras.
 - iv. To establish data-base/back-up in control room.
 - v. To establish control room(s).
 - vi. To install LED TV screens, UPS, dry batteries, etc. in control room(s).
 - vii. To maintain all the installed IT equipments for a period of one year.
1. Bids will be valid for a period of 90 days.
 2. Single-stage-two-envelop procedure as prescribed in Rule-38-2(a) PPRA, 2014 shall be followed. Tender containing technical & financial separate bids, duly completed, signed and stamped, sealed and in complete conformity with bidding documents should be submitted/furnished.
 3. The bids should be dropped in the tender box placed in the office of ADC(Finance), Deputy Commissioner's complex, Bhakkar, by closing date i.e. 05.09.2017 till 01.30 P.M. The tenders shall be opened publicly on the same day at 02:30 P.M. in the office of ADC (Finance), Deputy Commissioner's complex Bhakkar in the presence of all bidders who bother to attend.
 4. A complete set of bidding documents of the above mentioned tender containing detailed specifications of the I.T items and other terms and conditions can be purchased from office of District Nazir, DC's office, Bhakkar on or before closing date, by the interested bidders on submission of a written application on firm's letter pad at the address given below and upon payment of non-refundable fee of Rs.500/-. The bidding documents are available to the interested firms/prospecting bidders, immediately, after publication of this and can also be downloaded from PPRA website and District Bhakkar website (Bhakkar.gov.pk) after payment of the fee of Rs. 500/ in scheduled bank. The ADC (Finance), Deputy Commissioner's complex, Bhakkar can be contacted for any queries during office hours from 8:00 a.m. to 03:00 p.m. on any working day on Ph: No. 0453-9200312.
 5. The financial bids of the tender must be accompanied by a bid security of 2% of ADC (Finance), Deputy Commissioner's complex, Bhakkar.
 6. Tender received through telex/fax on after 11:00 A.M. of the closing date will not be entertained/considered.
 7. The procuring agency may reject any/all bidders or proposals at any stage, without giving any notice/justification.
 8. The quality of items can be verified as per requirement of the purchaser.
 9. No black listed firm can participate.
 10. The procuring agency may change the number of cameras/allied equipment, at the time of issuance of work order, as per need, given the prices reviewed.
